On March 03, 2025, the City Council of Eagle Grove, Iowa passed an ordinance, and a summary is as follows: SECTION 1. SECTIONS MODIFIED. Section 70.03 of the Code of Ordinances of the City of Eagle Grove, Iowa shall hereby be repealed and the following adopted in lieu thereof: 70.03 Parking Violations: Alternate. Uncontested violations of parking restrictions imposed by this Code of Ordinances shall be charged upon a simple notice of a fine payable at the office of the City Clerk. The simple notice of fine shall be in the amount of seventy-five dollars (\$75.00) for all violations except improper use of a persons with disabilities parking permit. If such fine is not paid within thirty (30) days, it shall be increased by twenty-five dollars (\$25.00). The simple notice of fine for improper use of a persons with disabilities parking permit is one hundred dollars (\$100.00). (Code of Iowa. Sec. 321.236[1b] & 321L.4[2]) SECTION 2. REPEALER. All ordinances or parts of ordinances in conflict with the provisions of this ordinance are here-by repealed. SECTION 3. SEVERABILITY CLAUSE. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional. #### SUMMARY OF ORDINANCE NO. 2025-01

An Ordinance Amending the Code of Ordinances of the City of Eagle Grove, lowa, by Amending Chapter 7.09 Setoff Program Provisions. On March 03, 2025, the City Council of Eagle Grove, Iowa passed an ordinance, and a summary is as follows: SECTION 1. SECTION MODIFIED. Section 7.09 of the Code of Ordinances of the City of Eagle Grove, Iowa, shall hereby be repealed and the following adopted in lieu thereof: 7.09 SETOFF PRO-GRAM PROVISIONS. This section shall establish policies and procedures for the City pursuant to Section 421.65 of the Code of Iowa, to allow the City to utilize and invoke the setoff program provisions of the State for collection of debts owed to the City and for which the City has provided the debtor with an opportunity to contest.1. Definitions. The following terms are defined for use in this section: A. "Debtor" means a person, not including a public agency, who has been determined to owe a qualifying debt. B. "Department" means the lowa Department of Revenue. C. "Public agency" means a board, commission, department, including the Department of Revenue, or other administrative office or unit of the State or any other State entity reported in the Iowa Annual Comprehensive Financial Report, or a political subdivision of the State, or an office or unit of a political subdivision. Public agency shall also mean the City Council, Utility Board of Trustees Commission, Official, Enforcement Officer, or any other term, individual, or board given powers to set from time-to-time fees, fines, or charges per the Municipal Code of Ordinances for the City of Eagle Grove. Public agency does include the Clerk of the District Court as it relates to the collection of a qualifying debt. Public agency does not include the general assembly or Office of the Governor. D. "Public payment" means any claim a public agency owes to a debtor. E. "Qualifying debt" means any of the following: (1) Any debt, which is assigned to the Department of Health and Human Services, or which is owed to the Department of Health and Human Services for unpaid premiums under Section 249A.3(2)(a)(1) of the Code of lowa, or which child support services is otherwise attempting to collect, or which foster care services of the Department of Health and Human Services is attempting to collect on behalf of a child receiving foster care provided by the Department of Health and Human Services. (2) Any debt which is in the form of a liquidated sum due, owing, and payable to the Clerk of the District Court. (3) Any debt identified in Section 7.09(3) Qualifying Debt. 2. Memo-randum of Understanding. The City shall enter into a memorandum of understanding with the Department which shall outline the program guidelines for use of the State Setoff Program. 3. Qualifying Debt. All debts or charges authorized herein by the Public Agency shall be deemed "qualifying debts" subject to the provisions of Section 421.65 of the Code of Iowa, for which the City shall provide those procedures as set out in this chapter. Such "qualifying debts" include, but are not limited to the following: (1). Past-due Utility Bills - water, sewer, storm water, landfill, and garbage services;(2). Past-due Connection fees, inspection fees, permit fees, private water line inspection and permitting fees, well fees, reconnection fees, shut off fees, late fees, water meter fee, utility deposit fees, disconnection fees, meter testing, sewer locating fees, trip charge and/or processing fees, meter tap fees, bulk water charges, abandonment of service fees, and offset program fee;(3).Past-due, unreturned (overdue) or damaged library materials or equipment;(4).Past-due parking tickets, snow ban ticket, police reports, motor vehicle impound fees, peddler's permit fees, transient merchant fees, fingerprinting fees, civil paper service fees, fireworks permit fees, golf cart permit fees;4.Past-due emergency medical services (ambulance) fees;(5). Past-due fire department fees, malicious false alarm fees, other false alarm fees, unlawful or uncontrolled grass fire fees, vehicle fire fees, extrication fees, structural fire fees, hazardous material mitigation fees;(6).Past-due fitness center memberships;(7).Past-due aquatic center season pass, entry fees, rental fees, lessons, or concessions;(8).Past-due park and recreation program fees, park shelter fees, ball diamond rental fees, facility rental fees, pool rental fees;(9).Past-due building permit fees, building permit violation fees, house mover fees, use permit fees, sign permit fees, Board of Adjustment fees, mobile food vendor fees;(10).Past-due rental license or rental inspection fees; (11).Past-due subdivision or planning fees including engineering fees incurred on behalf of the developer; (12).Past-due cemetery fee and invoices; (13).Past-due sidewalk repair or replacement costs;(14).Past-due sidewalk snow or ice removal invoice;(15). Past-due mowing invoice;16.Past-due nuisance abatement invoice;(17) Past-due animal impound fee invoice;(18).Past-due hazardous material mitigation fees;(19)Past-due Memorial Hall, Library, Museum, or other community facility rental fees, deposit fees, cleaning service fees, or disposal of left over items invoices;(20)Past-due junk dealer license;(21)Past-due sanitary landfill fees;(22)Past-due copy fee, returned check fee, public inspection fees;(23)Past-due solid waste noncompliance fees, administration fees, or collector's license fees;(24)Past-due costs, charges, invoices associated with development or sharing agreements;(25)Any debt which is in the form of a liquidated sum due, owing, and payable to the Clerk of the District Court; and (26)Any other liquidated sum certain, owing, and payable to the City with respect to which the City has afforded the debtor notice.4. Due Process. Unless otherwise required by the Code of Iowa, the City shall provide the debtor due process as outlined in this section prior to the sub-mission of a debt to the Department: (A)With respect to the qualifying debt, the City shall provide the debtor with 15 days' advance written notice to the debtor's last-known address. Such notice shall provide the debtor with a minimum period of 15 days in which they may file an appeal in writing to the Clerk. (B) Upon receipt of a written request for an appeal on a debt to be submitted to the Setoff Program the Clerk shall schedule a hearing with the Council, Utility Board of Trustees, or Commission responsible for overseeing the qualifying debt for the next regularly scheduled meeting and notify the debtor of the hearing date and time at least five days in advance of the hearing. (C) At the time and date of the hearing, the Council, Utility Board of Trustees, or Commission responsible for overseeing the qualifying debt shall hear any evidence brought forth by the debtor and shall examine the City's file regarding the matter. The Council, Utility Board of Trustees, or Commission responsible for overseeing the qualifying debt shall make a ruling upon a majority vote of the members in attendance. (D) If the qualifying debt is upheld by the Council, Utility Board of Trustees, or Commission responsible for overseeing the qualifying debt and the debt has not yet been paid by the debtor, the Clerk may certify the delinquency to the Department pursuant to the Section 421.65 of the *Code of Iowa* and the memorandum of understanding between the City and the Department. SECTION 2. RE-PEALER. All ordinances or parts of ordinances in conflict with the provi-sions of this ordinance are hereby repealed. SECTION 3. SEVERABILI-TY CLAUSE. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of the ordinance as a whole or any section, provision, or part thereof not adjudged invalid or unconstitutional.
