The Board of Supervisors met as Drainage District Trustees. To view the minutes from the drainage meeting, see the Drainage District minutes on the County website. Chairman Rasmussen called the

regular meeting of the Wright County Board of Supervisors to order at 9:05 a.m. Members present were Kluss, Bosch, Rasmussen, Loux, and Ellis.

Motion by Ellis and seconded by Loux to approve the tentative agenda. Motion carries.

Minutes of the previous regular meeting of June 9, 2025 were read and approved with corrections.

Approved claims for payment. Darrel Steven Carlyle, Wright County Economic Development Director, and Bruce Rholl, City of Woolstock Mayor, discussed with the Board the Urban Renewal Area for the City of Woolstock. Carlyle met with Rholl and the City Clerk to discuss the possibilities utilizing an Urban Renewal Area and TIF (Tax Increment Financing) for City of Woolstock. The City's water treatment plant is in need of repairs and utilizing these

could help repair the plant. Carlyle then presented Resolution 2025-23 giving consent that the City may exercise the Urban Renewal powers with respect to the said property. NOW, THEREFORE, it is hereby resolved by the Board of Supervisors of Wright County, Iowa, as follows: Section 1. The Wright County Board of Supervisors hereby gives its con-

sent that the City may exercise urban renewal powers pursuant to Chapter 403 of the Code of Iowa with respect to the Property situated in Wright County and outside the incorporated boundaries of the City. Section 3. This Resolution shall be deemed to meet the statutory requirements of paragraph 4 of Section 403.17 of the Code of Iowa and shall be effective immediately following its approval and execution. Steve Been, President of the Lake Cornelia Improvement Association, and other members of the Association met with the Board to discuss the warning system at Lake Cornelia. The current warning system was installed in 2008 and cost \$18,000 with a warranty of 5 years. The Association does not have insurance to cover the warning system but Wright County can carry the insurance because it is on County property. The batteries that were purchased by Wright County cost about \$480. Supervisor Rasmussen stated that there needs to be Lake Cornelia Improvement Association is not looking to pay for any improvements toward the current system or a new system. Been mentioned he would like to use the Grant Township budget to utilize dollars for the warning system. Electronic Engineering is coming in the near future to look at the current system and give an idea on what needs to be done. It was asked who currently owns the well at Lake Cornelia and Been responded the Lake Association has operational control over the well and is responsible for maintaining it. Supervisor Ellis will hold a meeting with the Association and the Township along with the Conservation Director to go over

Eric Simonson, Wright County Attorney, presented additional information on the agenda item that was tabled from June 2 nd to increase the annual salary of the Attorney's Office Manager. The Board asked that he review the budget for his department and see if it will be able to accommodate the raise. Simonson was able to review his budget and he does see that his budget will be able to handle a salary of \$59,000. Motion by Kluss and seconded by Ellis to approve the annual salary of \$59,000 for the Office Manager in the County Attorney's Office effective July 1 st, 2025. Motion carries. Adam Clemons, Wright County Engineer, presented fuel bids for Fiscal Year 2026. There were three bids submitted. Motion by Ellis and seconded by Kluss to accept the fuel bid with AgVantage FS at 0.079 cents over rack price on Gasohol, Premium Grade Diesel, and Artic Diesel. Motion carries. Clemons presented Resolution 2025-21, Adjustment to Specific Bridge Embargoes. Motion by Kluss and seconded by Loux to approve Resolution 2025-21. By roll call vote: Ayes - Kluss, Bosch, Rasmussen, Loux, and Ellis; Nays - none. Resolution 2025-21 duly passes and reads as follows:

passes and reads as follows: Resolution 2025-22 Policy for Drainage Tile Crossing and Parallel Tile within County Secondary Roads Right-of-Way

Be it resolved by the Board of Supervisors of Wright County, Iowa, to adopt the following road crossing with drainage tile policy for Wright County, Iowa.

WHEREAS, Chapter 318 of the Code of Iowa requires any person working within the right of way of a public road to obtain a permit from the highway authority having jurisdiction of the public road or high-

WHEREAS, Chapter 468 of the Code of Iowa prescribes a method for landowners to improve drainage by construction of filed tile through road right of ways, and

WHEREAS, The Wright County Board of Supervisors desires to create a road crossing with drainage tile policy which includes an option to expedite the procedures relating to projecting a drainage tile across a public highway to a suitable outlet.

THEREFORE, be it resolved and enacted by the Wright County Board of Supervisors that Wright County, Iowa, agrees, upon receipt of proper permit application, proof of contractor insurance, downstream landowner agreement, proof of contractor payment and completion per Wright County specifications to:

1. Pay 50% of the cost of materials and installation, up to \$2,000.00 for an open cut across the road right of way, and 50% of the cost of materials and installation, up to \$10,000.00 to bore across the road right of way.

2. Crossing under paved roadways shall be bored and crossing under gravel roadways may be open trenched. Surface material and seeding of disturbed areas are the responsibility of the applicant. Open trenching shall not be performed between November 15 th and April 1 st unless specifically authorized

by the County Engineer. 3. Pay \$300 towards the cost of material and installation of an intake in when specifically requested by the County Engineer.

4. Private tile placed to the road in the road right of way shall be at the cost of the applicant and future maintenance of the tile shall be assessed to the adjacent landowner. 5. Private tile shall not be permitted to be outlet into the road right

of way.

6. Tile installed parallel to the roadway in the road right-of-way shall be completed under a work in the rightof-way permit and shall be the sole responsibility of the owner of such tile. All costs of any maintenance work performed on a parallel tile by the county shall be the responsibility of the owner of such tile. Any maintenance work performed on the parallel tile by the owner of the

tile shall be performed under a work in the right-of-way permit. If a landowner chooses not to be bound by the above policy, then, the procedures for securing such crossing shall be in accordance with applicable Iowa Code Sections

468.600 through 468.622. A summary of those procedures is shown below:

1. File application in writing to the Wright County Auditor and provide the following information required by the Iowa Code 468.600. Include five copies of the following information:

a. Applicant(s)' name, address and a complete legal description of the property owned by the applicant. b. A complete and accurate legal description of the property across which the drainage improvements are proposed, including the names, address and phone numbers of all affected property owner(s) and or tenant(s), if applicable.

c. A detailed engineer's report, prepared by a Licensed Iowa Professional Engineer, showing the drainage area served by the existing drainage tile including the start point, route, terminus, character, size and depth of the existing drainage tile. d. A detailed engineer's report,

prepared by a Licensed Iowa Professional Engineer, showing the drainage area to be served by the proposed improvements including the starting point, route, terminus, character, size, and depth of the proposed drainage improvements. e. A detailed estimate giving the total cost of construction of the proposed drainage improvements with a separate, detailed estimate of the cost of the road crossing(s).

f. After the application materials has been submitted to the County Auditor and prior to scheduling the required public hearing, the Auditor will route the application materials to the County Attorney, County Engineer, and Natural Resources Conservation Service to review and submit comments or recommenda-

2. A public hearing shall be set by the Wright County Board of Supervisors pursuant to Iowa Code 468.601

3. File claims for damages at or before the hearing pursuant to lowa Code 468.601. 4. A public hearing shall be held

468.605. If the Board of Supervisors find that the purpose is to secure more complete drainage or a better outlet and the levee, open ditch, tile or other underground drain is found to be beneficial it will be approved. If the Board of Supervisors find the proposed drain runs in the course of natural drainage to a public road the over of such land shall have the right to enter upon such highway for the purpose of connecting the owners drain or ditch with any drain or ditch constructed along or across

said road.

prove the merits of the application, Iowa Code 468,606 shall be followed. The landowner, however in making such connections or crossing shall do so in accordance with specifications furnished by the Secondary Road Department at the time of filing a crossing application. 6. If the Board of Supervisors approve the tile line to be projected across the road right of way to a suitable outlet, the expense, of both material and labor used in installing the line across the highway and any subsequent repair thereof shall be paid from funds available for the highway affected. 7. If funds are not available in the

Wright County Secondary Road Fund for the reimbursement of the applicant for the cost of said tile crossing at the time of the construction of the crossing, it is understood the applicant will be reimbursed at such time as funds are available in the Wright County Secondary Road Fund. If is further understood that said reimbursements will be made in chronological order of approved and completed crossings 8. The Wright County Board of

Supervisors reserves the right to negotiate any type of cost sharing arrangement with the applicant and/ or to install the crossing with county staff or another contractor.

A completed application for drainage permit, including contractor's proof of insurance, and downstream property owner agreement are required. Upon completion of the crossing the applicant shall pay the Contractor and Wright County will pay the applicant.

FURTHER, THEREFORE, be it re-

solved and enacted by the Wright County Board of Supervisors that is policy shall not be construed as retroactive and shall apply to any permit applications made after the date by which the Resolution is passed. Dated at Wright County, Iowa this 16th day of June, 2025.
